**Subject: Proper implementation of CME Programme – reg.**

Sir/Madam,


It has come to the notice of RAV that many trainees are applying for multiple CME programmes, and in some cases, they are being selected by different organisations. Further, several trainees are attending multiple CME in a financial year without informing other institution about their participation in previous CME programmes. A trainee may attend maximum 2 CMEs in a financial year, subject to scrutiny for selection of trainees as per provision of scheme guidelines.

2. To ensure compliance with the Continuing Medical Education (CME) guidelines under the Ayurgyan scheme, grantee organizations are requested to:

- Verify Trainee Eligibility:** Confirm that selected trainees have not exceeded the maximum limit of attending 2 CMEs sponsored by Ministry of Ayush in a financial year, as per scheme guidelines.
- Obtain Undertaking from Trainees:** Get a proper undertaking from selected trainees before conducting the program, confirming they have not attended more than 2 CMEs in the current financial year.
- Disclosure by Selected Trainees of Upcoming CME:** If a trainee has already attended any CME recently or selected for upcoming CME, they must inform to other organizations about the same, where they have applied in the same financial year.
- Confirmation from Resource Persons:** You may take confirmation from Resource persons regarding the attendance in a financial year. Note: As per guidelines, the maximum limit for Resource person is 4 CMEs in a financial year.
- Grantee organizations are also requested to upload the list of selected Trainees on their website with Name, Designation & Current Posting.**
- Report to RAV:** If any organization finds that an individual has violated the scheme guidelines by concealing their previous participation, the matter may be reported to RAV along with relevant details. If needed, Grantee organizations may also contact RAV for further clarification (cme-ravdl@gov.in).

3. This measure aims to prevent trainees/Resource persons from attending more than the allowed number of CMEs in a financial year, ensuring adherence to scheme guidelines.
